If you have completed line 14 (Indiana), line 16 (Kentucky), or line 45 (Virginia) you must complete the above surcharge line.

Total Columns H, I, & J

Enter the taxable gallon figures from the diesel schedule (col. D) for Indiana, Kentucky and Virginia. Multiply the taxable

gallons from each state times the tax rate. Do not include the tax due from surcharges when calculating the total tax due (column H) for line 92001. Add the tax due (column H) for line 92001 to the tax due (column H) from surcharges and transfer this total, and the total from any other fuel schedule completed, to line 12 of Form 85. FOR EXAMPLE: If you have tax due for diesel on line 92001 in the amount of \$100.00 and tax due from surcharges in the amount of \$10.00 (Indiana), \$12.00 (Kentucky) and \$5.00 (Virginia), you would transfer the amount of \$127.00 to line 12 of Form 85.
