2011 KW-3/KW-3E SPECIFICATIONS FOR ELECTRONIC FILING

The Kansas Department of Revenue no longer accepts W-2s filed on magnetic media. Entities reporting for 51 or more employees or payees must file by electronic means.

In instances when it is determined it is not feasible to file using the Department's on-line web application, withholding information will be accepted on CD-ROM. Approval must be received from the Department in order to file on CD-ROM. Regardless of the submission method, records must meet the specifications outlined in the K-2MT and K-99MT documents for W-2 and 1099 electronic filing or the Department-defined comma separated value (CSV) file formats.

ELECTRONIC RECORDS THAT DO NOT CONFORM TO THE SPECIFICATIONS
 DEFINED IN THESE INSTRUCTIONS WILL NOT BE ACCEPTED.

Filers uploading withholding information for individual companies on the Department's website should complete the on-line KW-3 Annual Withholding Tax Return supplying applicable W-2 and 1099 information for those reports submitted. Filers submitting withholding information through an alternative method must submit KW-3 information in the Comma Separated Value (CSV) format outlined below. **Filers must contact Electronic Services when submitting information on CD-ROM.**
