- 7. Copy of the security agreement is NOT required.
- 8. If a legal document or power of attorney is used, please attach it to the application.
- 9. <u>Missing signatures and/or incomplete information VOIDS this application.</u>
- 10. If the current lien holder listed above fails to comply with the lien release requirements of KSA 8-1,157, the refinancing lien holder may file a complaint. If a complaint is not filed or a lien release is not received within 30 days, the application will be rendered incomplete, as certified above, and the registration cannot be renewed.
