Assembles and assimilates large quantities of data; discerns key issues and draws appropriate conclusions. Conducts investigations in a legally-sanctioned manner. Gathers, collates, organizes and analyzes information, conducts interviews, coordinates with law enforcement, prosecutors as well as other government agencies. Performs surveillance, and employs covert measures as necessary to document suspected incidences of criminal violations. Works cases in a timely manner. Maintains order and organization of complex case files. Protects the integrity and confidentiality of the investigative process and tax information.

Prepares written reports that are thorough, understandable, accurate, and properly formatted including but not limited to investigative narratives, memorandum of interviews, prosecution summaries and affidavits. Writes reports in a manner conducive for criminal or administrative prosecution. The elements of each violation are clearly outlined. Maintains up to date case files, documenting findings as the case develops, including updating case information contained in network folders. Provides routine updates to Chief Investigator. Presents results of investigations to the Chief Investigator and the appropriate prosecutor in a manner that ensures understanding. Appears in criminal court and administrative hearings as required, displaying a professional demeanor and appearance.
19%	Conducting Interviews. Interviews witnesses and suspects in a manner that maximizes opportunities to determine the truth and that meets legal requirements. Adapts interviewing approach and techniques to fit the dynamics of the situation and interviewee. Applies training and experience in an effective and efficient manner. Performing Criminal Enforcement Activities. Performs functions relating to arrests, the execution of arrest warrants and search warrants, as well as the use of force in a professional, safe and legally sanctioned manner. Authors and follows operational plans in an organized fashion.
8%	Cultivating a trusting/collaborative working rapport with key partners. Routinely communicates and works with Homeland Security Investigations, the SSA Office of Inspector General (OIG), FBI, State Department, Citizenship and Immigration Services Fraud Detection and National Security, U.S. Department of Labor OIG on the federal level as well as the KBI, Kansas Attorney General's Office and other state law enforcement agencies, as well as and law enforcement officers from Kansas sheriff's offices and police departments. Works with district and county attorneys as well as the U.S. Attorney's Office during the development of cases to maximize opportunities for successful prosecution should criminal violations be found. Investigates complaints from the public including misrepresentation of a vehicle, odometer fraud, salvage fraud, unlicensed salespersons, curbstoning and alleged sales tax violations
13%	General Support to Unit. Assist with the operation of the Office of Special Investigations as assigned by Chief Investigator. This includes, but is not limited to providing Spanish interpreter services; conducting security clearance background investigations, performing research, and helping staff complete their duties effectively. Professional Performance. Executes duties with integrity and honesty.
